1. After the career talk in school, the committee meeting commenced at 6:20pm. Chairman welcomed members to the meeting.

Visit

2. Chairman recapitulated the visit to Daya Bay Nuclear Power Plant on 1 December 2007

Past athletes

3. Chairman reported on the meeting with former /past athletes at school on 21.12.07, and would attempt more interaction and personal communication with them with a view to inviting them to join the OBA. Mr. Tsang Ting Fung, one of the past athletes, was a football coach and had volunteered to offer free coaching sessions, and organize football matches/events. Vincent Lau would assist to contact past athletes, including Roy Wong. Reference should be made to the book of athletes as well as the school's web page on this activity.

School Executive Committee (校政執行委員會)

4. Ms YY Chan, Vice Principal explained the function of the School Executive Committee (SEC) which is under the Board of Governors of the school. The meeting unanimously agreed that the Chairman was the most appropriate person and should continue to attend the SEC meetings, which are held 3 times a year. In case the Chairman was on leave, the Vice Chairman would deputize and attend the meeting. Chairman would reflect OBA's view especially on sports and in the fund allocation.

OBA Sponsorship and subsidy to school functions

5. After deliberation of the 4 proposed events put forth by Vice Principal and having considered the budget, the meeting decided to subsidize Events ,2, 4 and 5 as well as including item 6 to a total of \$23,000.. This is in addition to item 1 which is an OBA scholarship for outstanding athletes donated personally by the Chairman (\$6,000 for individuals and \$4,000 for teams). The overall position is summarized as follows:

6. Item 3 was a remedial class for F1 to F3 students of poor performance requiring a total cost of \$26,000. In Item 3 OBA was requested to contribute a subsidy of \$6,000 to top up the \$20,000 allocated by the school funding. The meeting

decided not to subsidize item 3.

7. The meeting decided that the annual expenditure of the OBA should not exceed \$30,000 ceiling.

Financial position

8. With the current balance of \$55,000 based on Paul's financial report, the opening balance for next year would then be around \$32,000(i.e. \$55,000 less \$23,000 total expenditure for current year). With the lower opening balance, fund raising would be required for the next session.

- 9. The meeting also noted the proposal for the renovation of the changing room. As this would involve extensive commitment, the meeting decided not to take it up. Instead advice or assistance might be sought from old boy Mr. CF Ho, Chief Project Manager of ArchSD, who was working on school improvement. Raymond Tang was asked to seek the advice from Mr. CF Ho to see how possible application might be initiated from Education Department.
- 10. There being no further business, the meeting closed at 7:30pm and group photos were taken.
